END USER LICENSE AGREEMENT

IMPORTANT-READ CAREFULLY

COMPASSDATA, INC. (CDI) IS WILLING TO LICENSE THE GEOGRAPHIC DATA AND RELATED MATERIALS TO LICENSEE ONLY ON THE CONDITION THAT LICENSEE ACCEPT ALL OF THE TERMS AND CONDITIONS CONTAINED IN THIS CDI DATA LICENSE AGREEMENT. BY SIGNING OR OTHERWISE INDICATING ACCEPTANCE OF A CUSTOMER AGREEMENT OR DOWNLOADING, ACCESSING OR USING ANY GEOGRAPHIC DATA PRODUCTS, YOU ARE ACCEPTING AND AGREEING TO BE BOUND BY THE TERMS OF THIS AGREEMENT. PLEASE READ THE TERMS AND CONDITIONS CAREFULLY.

CompassData, Inc. License Agreement

This is a license agreement and not an agreement for sale. This license agreement (Agreement) is between the end user (Licensee) and CompassData, Inc. (CDI), and gives Licensee certain limited rights to use the proprietary CompassData, Inc. geographic data and/or hard-copy documentation and user guides, as applicable (hereinafter referred to as "Data, and Related Materials"). All rights not specifically granted in this Agreement are reserved to CDI.

Reservation of Ownership and Grant of License: CDI and its third party licensor(s) retain exclusive rights, title, and ownership of the copy of the Data, and Related Materials licensed under this Agreement and, hereby, grants to Licensee a personal, nonexclusive, unrestricted, royalty-free, fully-paid perpetual license to use the Data, and Related Materials in the Licensee products and for in-house use based on the terms and conditions of this Agreement. The Licensee shall have no rights to resell, license or otherwise provide CompassData data or materials to customers without the express, written consent and compensation to CompassData. Any and all Intellectual Property, made or conceived of or reduced to practice or learned by CompassData, either alone or jointly with others, during the term of this agreement in the course of performing the effort hereunder shall remain the sole and exclusive property of CompassData, Inc. From the date of receipt, Licensee agrees to use reasonable effort to protect the Data, and Related Materials from unauthorized use, reproduction, distribution, or publication.

Copyright: The Data and Related Materials are owned by CDI and are protected by United States copyright laws and applicable international laws, treaties, and/or conventions.

Third Party Beneficiary: CDI is authorized to redistribute and license third party (hereinafter referred to as "Third Party Beneficiary") data component(s) that is (are) delivered with the Data, and Related Materials provided under this Agreement. The Third-Party Beneficiary shall have the right to enforce this Agreement to the extent permitted by applicable law.

Permitted Uses:

Licensee may install and use Data and Related Materials, or any prior version solely for in-house use.

Licensee may also store or install a copy of the Data and Related Materials on a storage device, such as a network server, used only to access the Data and Related Materials on Licensee's other computers over an internal network.

Licensee may not transfer the other media to another user. Licensee may make routine computer backups of the Data and Related Materials for archival purposes during the term of this Agreement.

Licensee may use, copy, alter, modify, merge, reproduce, and/or create derivative works of CDI data solely for Licensee's own internal use. The portions of the CDI data merged with other hard-copy and/or digital materials shall continue to be subject to the terms and conditions of this Agreement and shall provide the following copyright attribution notice acknowledging the proprietary rights of CDI and its third party licensor(s) in the documentation: "Portions of this document include intellectual property of CDI and its licensor(s) and are used herein by permission. Copyright (c) 2018 CompassData, Inc., and its licensor(s). All Rights Reserved."

Uses Not Permitted:

Licensee shall not sell, rent, lease, sublicense, loan, lend, assign, time-share, or transfer, in whole or in part, or provide unlicensed third parties access to prior or present versions of Data and Related Materials, any updates, or Licensee's rights under this Agreement.

Licensee shall not remove or obscure any CDI and its licensor(s) copyright, trademark, and/or proprietary rights notices.

Licensee shall not reverse engineer, decompile or disassemble the provided data, or otherwise tamper with the provided data to create any ground control like products therefrom.

Term: The license granted by this Agreement shall commence upon Licensee's receipt of the Data and Related Materials and shall continue until such time that (1) Licensee elects to discontinue use of the Data and Related Materials from this Agreement or (2) CDI terminates for Licensee's material breach of this Agreement. Upon termination of this Agreement in either instance, Licensee shall return to CDI Data Related Materials, and any whole or partial copies, codes, modifications, and merged portions in any form. The parties hereby agree that all provisions, which operate to protect the rights of CDI and its licensor(s), shall remain in force should breach occur.

Limited Warranty: CDI warrants that the media upon which the Data and Related Materials are provided will be free from defects in materials and workmanship under normal use and service for a period of sixty (60) days from the date of receipt. If included in the CDI package, the Data herein have been obtained from sources believed to be reliable, but its accuracy and completeness, and the opinions based thereon, are not guaranteed. Every effort has been made to provide accurate Data in this package. The Licensee acknowledges that the Data may contain some nonconformities, defects, errors, and/or omissions. CDI and its licensor(s) do not warrant that the Data will meet Licensee's needs or expectations, that the use of the Data will be uninterrupted, or that all nonconformities can or will be corrected. CDI and its licensor(s) are not inviting reliance on these Data, and Licensee should always verify actual map data and information. The Data contained in this package are subject to change without notice.

EXCEPT FOR THE ABOVE EXPRESS LIMITED WARRANTIES, THE DATA AND RELATED MATERIALS CONTAINED THEREIN ARE PROVIDED "AS IS", WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE.

Exclusive Remedy and Limitation of Liability: During the warranty period, CDI's entire liability and Licensee's exclusive remedy shall be the return of the license fees paid for the Data and Related Materials in accordance with the CDI Customer Assurance Program for the Data and Related Materials that do not meet CDI's Limited Warranty and that are returned to CDI or its resellers with a copy of Licensee's proof of payment.

CDI SHALL NOT BE LIABLE FOR INDIRECT, SPECIAL, INCIDENTAL, OR CONSEQUENTIAL DAMAGES RELATED TO LICENSEE'S USE OF THE DATA AND RELATED MATERIALS, EVEN IF CDI IS ADVISED OF THE POSSIBILITY OF SUCH DAMAGE. THESE LIMITATIONS SHALL APPLY NOTWITHSTANDING ANY FAILURE OF ESSENTIAL PURPOSE OF ANY LIMITED REMEDY.

Waivers: No failure or delay by CDI or its licensor(s) in enforcing any right or remedy under this Agreement shall be construed as a waiver of any future or other exercise of such right or remedy by CDI or its licensor(s).

Order of Precedence: Any conflict and/or inconsistency between the terms of this Agreement and any FAR, DFAR, purchase order, or other terms shall be resolved in favor of the terms expressed in this Agreement, subject to the U.S. Government's minimum rights unless agreed otherwise.

Export Regulations: Licensee acknowledges that this Agreement and the performance thereof are subject to compliance with any and all applicable United States laws, regulations, or orders relating to the export of Data and Materials or know-how relating thereto. CDI Data and Related Materials have been determined to be Technical Data under United States export laws. Licensee agrees to comply with all laws, regulations, and orders of the United States in regard to any export of such Technical Data. Licensee agrees not to disclose or reexport any Technical Data received under this Agreement in or to any countries for which the United States Government requires an export license or other supporting documentation at the time of export or transfer, unless Licensee has obtained prior written authorization from CDI and the U.S. Office of Export Control. The countries restricted at the time of this Agreement are Crimea – Region of Ukraine, Cuba, Iran, North Korea, Syria and Sudan.

U.S. Government Restricted/Limited Rights: If provided to the U.S. Government, any documentation and/or data delivered hereunder is subject to the terms of the License Agreement. In no event shall the Government acquire greater than RESTRICTED/LIMITED RIGHTS. At a minimum, use, duplication, or disclosure by the U.S. Government is subject to restrictions as set forth in FAR §52.227-14 Alternates I, II, and III (JUN 1987); FAR §52.227-19 (JUN 1987) and/or FAR §12.211/12.212 (Commercial Technical Data/Computer Software); and DFARS §252.227-7015 (NOV 1995) (Technical Data) and/or DFARS §227.7202 (Computer Software), as applicable. Governing Law: This Agreement is governed by the laws of the United States of America and the State of Colorado without reference to conflict of laws principles.

Entire Agreement: The parties agree that this constitutes the sole and entire agreement of the parties as to the matter set forth herein and supersedes any previous agreements, understandings, and arrangements between the parties relating hereto and is effective, valid, and binding upon the parties.
